# An Active Citizen, Al Schlueter, Establishes Two Funds with the Foundation

Well-known to his fellow villagers as an active citizen, in 2014 Al Schlueter established two new funds with the Yellow Springs Community Foundation in honor of his parents, Dorothy and William Schlueter. During the great depression, Al's father, William, had to quit school after completing eighth grade in order to work and help his family. While William never felt financially secure, he and his wife, Dorothy, who at one time taught in a one-room schoolhouse, worked hard, saved, and lived frugally. William, with his brothers and sisters, eventually established a family corporation to develop their family farm. They built a grocery store and homes on the farm on which they grew up.

The result of their efforts was that Al's father and mother were able to leave Al an inheritance that he feels he did not earn. Since the funds did not come from his efforts, Al wanted to donate them to charities that would have appealed to his parents and would also benefit the community he loves and calls home. After discussing the matter with a financial advisor, Al decided it would not be practical to establish a family foundation, so he looked into other family philanthropy options with another community foundation in the area. He found the discussions very helpful, but wanted to give in a way that would more directly benefit his own community, Yellow Springs.

Following discussions with Sterling Wiggins, a neighbor in past years and now president of YSCF, Al realized he could establish the same type of funds with the Yellow Springs Community Foundation as he could elsewhere, and be assured the funds would remain in the village, always benefitting his home community.

Al has established two different types of funds. The *Dorothy and William Schlueter Donor Advised Fund* allows Al and his son, Eric, to "have a more direct say" in where funds will be granted. He can request that funds be given to specific nonprofit charities, and with YSCF Board approval, the funds will be dispersed as requested. That gives Al a feeling of greater connection to the town and to causes he, his son, and his parents have long valued. This is a non-endowed or expendable fund that is eligible to receive donations from the general public, as well as from the Schlueters.

Donor advised funds may be permanently endowed funds or expendable funds. Either way, they allow the donor to recommend grants from year-to-year for qualified purposes of the foundation and/or other qualified tax-exempt charities or purposes.

The second fund is the *Dorothy and William Schlueter Field* of *Interest Endowment Fund*. The purpose of this endowment is to generate income to support education, affordable housing, the arts, and projects that connect the community to Antioch College. The Yellow Springs Community Foundation will use the income earned by the endowment to fund grant requests supporting any of the areas of interest without a request from Al. Donors may also earmark gifts to the foundation to be applied to this endowment fund.



Pursuant to current foundation policies, a minimum gift of \$25,000 is required to establish an expendable donor advised fund or an endowment.

Both of the Schlueter funds will support the activities of nonprofit organizations that make the village a vibrant, desirable place to live. By choosing to establish these two funds with the Yellow Springs Community Foundation, Al has contributed to the growth of the only community foundation established specifically to enhance life in the Village of Yellow Springs and Miami Township.

## Antioch College Wellness Center and Tennis Courts

2014 was a big year for wellness and fitness in the Yellow Springs Community! The Antioch College Wellness Center, formerly known as the Curl Gymnasium, opened to community celebration in September. The Antioch College tennis courts were fully restored and celebrated the 1<sup>st</sup> Annual Town and Gown Tennis Tournament. The Yellow Spring Community Foundation was instrumental in these projects through grants of \$40,000 for the Wellness Center renovation, and \$10,000 for the tennis courts.

There are currently 1,906 members of the Wellness Center, including faculty, staff, and students at the college. This is a benefit to Yellow Springs and surrounding areas. Megan Rehberg, Antioch College Foundation Relations Officer, wrote: "The Wellness Center has contributed to a revitalized sense of community between the college and the village. The tennis complex is a gathering place for tennis enthusiasts and a cultural melting pot for strengthening social bonds."

The 44,000-square-foot center features a six-lane, regulationlength indoor swimming pool, a therapeutic whirlpool, a fitness room with state-of-the-art equipment, studio space, and a space for special events and performances. It's also a new place for community events. The YSCF 40<sup>th</sup> Anniversary Celebration was hosted in the new multipurpose room, and the building will be a key feature in Antioch College's 2015 reunion and first commencement since reopening.

The Wellness Center is a marvelous example of the YSCF mission in action. Monica Hasek, the director, said, "The Wellness

Center at Antioch College has been all that we had hoped and more as a place for community members and the college to socialize, play, and recreate together. We are proud to be the new venue in town where people come together and support one another in health and wellness. It is inspiring to see so many people, young and old, having fun and utilizing our beautiful facility."

Mark Roosevelt, president of Antioch College, had this to say about the role that the YSCF plays in the Antioch College and Yellow Springs community: "Our partnership with the Yellow Springs Community Foundation has drawn the village and the college even closer. Working with the YSCF has helped us realize the benefits of sharing our resources. I believe everyone now realizes that the village and the college grow stronger by working together, and often the YSCF is the engine that drives that collaboration."

The Wellness Center and tennis courts fulfilled the Antioch College vision to contribute to a revitalized sense of community between the college and the village by creating a community/college collaborative effort, sharing college assets with Yellow Springs and the surrounding area. The YSCF is proud to have been a part of it.

## **Our New Website**

## **Introducing Recent Trustees**

The foundation has a newly refreshed and updated presence in cyberspace, thanks to the recent launch of a new website. The web site address, <u>www.yscf.org</u>, has not changed, but everything else about the site is completely new. The Foundation engaged Bing Design of Yellow Springs to come up with a new, modern design built on the popular WordPress content management system used by almost 25 percent of the top 10 million websites.

Besides the updated look and feel, the new site also provides increased functionality in several key areas. The new site now includes the ability to accept online donations using PayPal and any major credit card with the full security PayPal is known for. Behind the scenes, donation information is then moved directly into the foundation's Salesforce.com-based back-office system, where it is credited to the appropriate donor and/or organization.

Grant-seeking groups and organizations can now also use the site to submit their grant applications online, including the necessary attachments, such as financial information and other required details. Grant applicants can start, stop, and then re-start the application if necessary before final submission. When the submission is made, grant application details then are automatically loaded into the Salesforce.com-powered back-office management system, where the relevant data about the application is then immediately available to the foundation administrator and all trustees.

Another significant improvement the updated site brings is the ease with which changes to the site can be made. "We have total control now and it is much easier for us to make changes," said Virgil Hervey, foundation administrator. "I can modify everything about the website and do not have to wait on someone else to make changes or add new content. We can easily add an unlimited number of new menus, pages, and complete sections when needed."

The new site also makes it much easier to integrate video and other media, such as the 40<sup>th</sup> Anniversary Videos currently highlighted on the home page. A number of other features are also available and may be implemented over time, such as visitor comments, events, and blog posts. Because the site is built on the WordPress platform, literally thousands of plug-in applications and tools can be added to enhance the experience for both visitors and the site administrators.

**Jane Scott** served this past year as an emeritus trustee. ## **Peace Project**

Mills Lawn Elementary School was awarded a grant by the Community Foundation, from its Yellow Springs Endowment for Education (YSEE).

The project had two phases: Phase I—Artist in Residency 2013, "Confronting Bullying through Art & Action" research project; and Phase II—"What Does Peace Look Like at Mills Lawn?"

The first phase of the Peace Project focused on the Mills Lawn 6th-grade class. This art-based program, led by graduate student and researcher Allison Paul, along with guidance counselor John Gudgel, empowered students to understand bullying behavior and cultivate empathy and understanding. Students were asked to explore the question "What challenges are you facing as students at Mills Lawn?" Through art, role playing, and team-building games, students became aware of ways they could speak out against intimidation and stand up for others. They were charged with reflecting, analyzing, and acting on issues in their school community, empowering them to be change makers in school culture.

Throughout the school there were artistic opportunities for all grades to engage in being peacemakers. Students created indigo-dyed peace messages and designed their own peace symbols modeled after West African Adinkra symbols. One group drew self-portraits, highlighting their qualities that embody a hero/peacemaker. Other students created a powerful mixed-media tryptich of iconic peacemakers, Gandhi, Martin Luther King Jr., and Rosa Parks.

#### Phase II: "What Does Peace Look Like at Mills Lawn?"

"Don't be a bystander, be an upstander." This is a phrase you frequently hear at Mills Lawn Elementary these days. Phase II of the Peace Project's goal was to continue to empower students with tools, particularly vocabulary and language, to use as peacemakers.

Sixth-grade students designed a Powerful Peace Wheel as a way for students to talk about conflict resolution. The wheel includes: Walk Away; Ask Them to Stop; Apologize; Make a Deal; Share/Take Turns; 3 Deep Breaths; Go to Another Activity; and Peace Place. Peace Place is a safe space for individuals or a place two people can go to deal with a conflict. Since its introduction, the Peace Wheel has become second nature to students in learning to deal with conflict.

According to Principal Matt Housh, Guidance Counselor John Gudgel, and resident artist and researcher Allison Paul, students have gained considerable skills to deal with gossip and bullying


grant requests every month and has granted requests totaling over \$260,000 this past year—a far cry from the first \$2,000 gifted in 1975. Given the diversity of funding, there is hardly a Yellow Springs nonprofit organization that has not benefited from funds given by YSCF or hardly a person who lives in this community who has not been touched, directly or indirectly, by the Yellow Springs Community Foundation."
